Onsite Soil Evaluator News and Notes: by Jeff T. Walker, LPSS/OSE

VDH's CBEP* Technical Advisory Committee was charged with participating in revisions to the Sewage Handling and Disposal Regulations under HB 1726. These measures were presented to the Board of Health. (* Chamber, Bundle and Extruded Polystyrene)

Amongst our comments addressing proposed regulations have been: requirement for design changes to be specified and endorsed by OSE/PE, provisions for selecting loading rates for soil textures, organic loading calculation for soil structure or pore space, energy dispersal for dosed systems, additional restrictions on use in special situations.

SHIFT report: having participated in three of a series of seven meetings administered by the Institute for Environmental Negotiation under contract with the VDH. You may wish to follow our progress here: http://www.vdh.state.va.us/EnvironmentalHealth/Onsite/SHIFT/

We have come to consensus over the two primary roles, regulatory oversight, and design. Increasing private sector participation may require Legislation; however there are areas which can be addressed under existing VDH authority. Legislative issues are primarily fees, budgetary impact or delegated authorities. Recently VDH was given authority to issue fines and penalties against citizens who are not compliant with Sewage Handling Regulations. Thereby clarifying who's responsible for "sewage on the ground," it's homeowners. There is resistance from localities and builders reluctant to give up subsidized services, estimated at 80% tax funded.

Regulatory considerations are being identified and segregated from further SHIFT discussions; VDH has staff capable of forging the required language, and policy bodies to identify issues.

DPOR OSE licensure has been harder to discuss since defining the scope of work product expectations is not complete, and relies upon continuing evolution of our regulatory body's policies and regulations. Other DPOR Boards have experience in the technical, ethical and procedural requirements including PE and PSS. Mark Courtney, Director of Enforcement; explains that VDH employs code officials who bear responsibilities, which cannot be assigned to DPOR.


"Oversight of DPOR licensees—in terms of their performance of services that are controlled by other entities such as VDH—is not reserved solely to DPOR. DPOR's role in regulating professional standards of practice does not extend to interpreting or enforcing statutes, regulations, policies, or procedures under the purview of other agencies."

"In the case of licensed Onsite Sewage System Professionals (OSSPs), VDH is indeed authorized to provide oversight or to require continuing education in exercising its mandate to protect public health and groundwater supplies in the Commonwealth. Complaints processed by DPOR are limited to those involving alleged regulatory violations of standards of practice and minimum professional competency."

Consequently the potential conflict of interest is broader than originally debated. Code officials have duties which may conflict with design and site evaluation responsibilities for a private landowner. Never-the-less we understand that the design authority is vested in all licensed OSE, provided their work bears identification.

Data sets which VDH has delivered to the SHIFT have been informative. During the past year only 58% of permits statewide were delivered within the 15 working day expectation. Ironically the newest backlog data shows that some low participation regions experience backlog, which by law (SB415 of 1994) was meant to establish priorities, and trigger sub-contracting of services through OSE designers. (SB415 was also an early mention of CPSS' role in site evaluation.)
